Chris has closed over \$100M in acquisitions including two financial service companies, a software development company, a digital marketing company, two casinos and a gaming distribution company. He transitioned a company from the OTC to Amex Exchange while growing the market cap from \$20M to \$250M. Chris was integral in merging two private companies and taking them public through a reverse merger where he subsequently completed a convertible preferred stock offering. He has completed \$210M in senior debt financing and managed a large casino development project which was then funded through the issuance of \$200M in high yield debt.

Chris Domijan's proven strengths in corporate development are supported by his visionary focus on growth strategies through profitable organic or tactical acquisitions and his ability to access capital markets for debt or equity to fund those growth strategies.
